My kennel hours are 8:00 – 4:30 Monday –Friday and are set by appointment. No Sunday appointments.

I agree to exercise due and reasonable care and to keep my kennel premises sanitary and properly enclosed. The dog is to be fed properly, and to be housed in clean and safe quarters. My staff and I agree that dogs trained for hunt tests or field trials will be charged a handling fee for test and competitions. The weekend handling fees will be \$70.00 per dog per weekend and a share of expenses (gas and lodging).

Any dogs trained for test or gun dog will be billed for birds that are shot for their dog which is normally 2 birds per month and in some cases more if more if needed. The average price is \$12.50 or according to market price for birds. All dogs are trained, or otherwise handled or cared for by me and/or my staff without liability on our part for loss or damage from disease, injury, death, running away, theft, fire, injury to persons and /or property by said dog, or other unavoidable causes, due diligence and care having been exercised.

If said dog becomes seriously ill, the owner shall be notified at once in case no particular veterinarian has been designated. If the owner does not act immediately regarding measures to be taken, or if the state of the dog's health reasonable demands quick actions, I shall have the right to call a veterinarian, as designated above, or if no veterinarian is designated to call a veterinarian of choice or take the dog to said veterinarian in either case; or administer medicine or give other advisable attention, within my discretion and judgement, and such expenses shall be paid by the owner of the dog.

All heartworm preventative and flea and flea and tick (Frontline) is the responsibility of the owner. If it is not provided by dog owner then the expense will be added to the dog owner's monthly bill.

A monthly training fee of \$_____ is required at the beginning of every month. The first month training is due when the dog is delivered to the kennel. Any fees over 15 days late will result in dog not being trained until payment is made in full.
